


The International Council of Accreditation (ICA) released the new *Standards and Criteria for Accreditation* on November 21, 2018, to all Program and Medical Directors, and posted on ICA's website for public view. To download and review the new *Standards and Criteria*, please visit ICA's website at www.icaccreditation.org.

All comment or concerns regarding the new Standards and Criteria must be submitted to ICA in formal letter format stating which Standard you are questioning, reason, and recommendations. All letters must be submitted to ICA **before December 31, 2018**. Any letters received after this date will not be reviewed. The Public Hearing will be scheduled for the evening of Wednesday, January 16, 2019, at 7:00 p.m. Central Standard Time. The ICA Board will review all feedback before starting the Public Hearing process.
